# **EXECUTIVE SUMMARY**

This Public Participation Plan (PPP) has been prepared by The Goodyear Tire & Rubber Company ("Goodyear" or "Applicant") to fulfill and comply with the requirements of New York State Department of Environmental Conservation ("NYSDEC") Commissioner Policy 29, *Environmental Justice and Permitting* (CP-29). This PPP is submitted to the NYSDEC as a requirement of the Air State Facility (ASF) Permit modification and renewal application for Goodyear's manufacturing facility located at 5500 Goodyear Drive in Niagara Falls, New York. Based on the location of the Applicant's facility, CP-29 requires Goodyear to prepare and submit this PPP to the NYSDEC Regional Permit Administrator for review, approval, and implementation because the Goodyear Niagara Falls facility is located in or could affect one or more Potential Environmental Justice Areas (PEJAs) or Disadvantaged Communities (DAC).

This PPP has been developed in accordance with the procedures established in CP-29 Section V.D with the objective of helping ensure meaningful and effective public participation throughout the NYSDEC's environmental permit review process. Public participation in the NYSDEC environmental permit review process requires a program of activities that provides opportunities for stakeholders to be informed about and involved in the review of a proposed permit action.

This PPP outlines and describes the program of activities that Goodyear will implement to actively seek and enhance public participation during the application review process.



# 1. INTRODUCTION

#### 1.1 PROJECT OVERVIEW

This Public Participation Plan (PPP) has been prepared by The Goodyear Tire & Rubber Company ("Goodyear" or "Applicant") to fulfill and comply with the requirements of New York State Department of Environmental Conservation ("NYSDEC" or the "Department") Commissioner Policy 29, Environmental Justice and Permitting (CP-29). This PPP is submitted to the NYSDEC as a requirement of the Air State Facility (ASF) Permit modification and renewal application for Goodyear's manufacturing facility located at 5500 Goodyear Drive in Niagara Falls, New York. Based on the location of the Applicant's facility, CP-29 requires Goodyear to prepare and submit this PPP to the NYSDEC Regional Permit Administrator for review, approval, and implementation because the Goodyear Niagara Falls facility is located in or could affect one or more Potential Environmental Justice Areas (PEJAs) or Disadvantaged Communities (DAC).

This PPP has been developed in accordance with the procedures established in CP-29 Section V.D to help ensure meaningful and effective public participation throughout the NYSDEC's environmental permit review process. Public participation in the NYSDEC environmental permit review process requires a program of activities that provides opportunities for stakeholders to be informed about and involved in the review of a proposed permit action.

#### 1.2 PUBLIC PARTICIPATION PLAN OBJECTIVE

The objective of this PPP is to outline and describe the program of activities that Goodyear will implement to actively seek and enhance public participation during the permit application review process.

In accordance with CP-29, Section V.D, a PPP must demonstrate that the applicant has and/or will:

- 1. Identify stakeholders to the proposed action, including residents adjacent to the proposed action site, local elected officials, community-based organizations, and community residents;
- 2. Distribute and post written information on the proposed action and permit review process. The applicant shall present information in an easy-to-read, understandable format, using plain language and, if appropriate, public notice materials shall be translated into language(s) other than English for comprehension by non-English speaking stakeholders;
- 3. Hold at least one public information meeting to keep the public informed about the proposed action and permit review status, which would be held during the permit review process at a location and time that is convenient to the stakeholders of the Project;
- 4. Establish an easily accessible document repository in or near the Potential Environmental Justice Area to make available pertinent Project information, including but not limited to:



application material, studies, reports, meeting presentation materials, and media releases. Materials must also be made available through an online [internet-based] repository.

In addition, the Applicant is required to submit a report that summarizes:

- a. the progress to-date in implementing the plan;
- b. the substantive concerns raised to-date;
- c. any/all resolved and outstanding issues;
- d. the components of the plan yet to be implemented; and
- e. an expected timeline for completion of the plan.

Upon completion of the PPP, Goodyear will submit written certification that it has complied with the plan as well as a revised report detailing activity that occurred subsequent to the initial submission of the report. The certification will be submitted to NYSDEC prior to a final decision on the proposed permit application.

# 2. PROJECT DESCRIPTION AND PROPOSED ACTION

#### 2.1 PROJECT OVERVIEW

Goodyear owns and operates a manufacturing site located at 5500 Goodyear Drive in the City of Niagara Falls, New York (the "Facility"). The Facility was originally built in 1946 for polyvinyl chloride (PVC) manufacturing and began production of rubber antioxidant products in 1957. Although PVC production was discontinued in 1996, the Facility continues to manufacture an antioxidant product. The Facility is located on 28 acres of land encompassing 210,000 square feet of building space that contains three reactor systems. The Facility has two finishing lines that manufacture the following Goodyear Chemical product:

#### POLYSTAY® 100

Goodyear is seeking to modify and renew the Facility's existing Air State Facility Permit (9-2911-00036/00151), which became effective on June 15, 2009, with no expiration date assigned to the ASF Permit by the NYSDEC at the time of permit issuance. In 2018, the NYSDEC Division of Air Resources (DAR) requested Goodyear apply to renew the ASF Permit in accordance with regulatory updates to Title 6 of the New York Code, Rules, and Regulations (6 NYCRR) Part 201 to establish 10-year term limits to ASF permits issued by the NYSDEC.

On January 14, 2025, Goodyear entered into an Order on Consent (Order No. R9-20241125-128, hereafter referred to as the "Order") with the NYSDEC requiring Goodyear to submit an Air Pollution Control Engineering Study ("the Study") to the DEC within 60 days of the effective date of the Order. The Order required the Study to include the details and schedule needed for the design, procurement, installation, commissioning, and performance emissions testing of the upgraded emission sources and permanent control technology.



The Study conducted by Goodyear proposed to replace the existing Tri-Mer WhirlWet® Scrubber with a new wet scrubber and incorporate a new Regenerative Thermal Oxidizer (RTO) into the air emissions control systems for the equipment that exhausts through the current Tri-Mer WhirlWet® Scrubber and to redirect the air emissions from the Elimination Tank No. 2 through the new RTO as well. The replacement wet scrubber and the new RTO are air emissions control devices that will be designed, engineered, and installed to capture and control air particulates and organic air contaminants from the Facility. Once these upgraded air emissions control systems are in place, the resultant facility-wide air emissions profile from the Facility are expected to demonstrate compliance with the regulatory requirements of New York Part 212 for Air Emissions from Process Sources.

The Order also requires Goodyear to submit to the DEC within 45 days of the Department's approval of the Study "an application that includes the information regarding the renewal and modification of the air permit detailing equipment changes and emission calculations, an AERMOD modeling protocol, CLCPA analysis following the procedures described in DAR-21 and DEP-24-1, and a Public Participation Plan pursuant to CP-29."

This document fulfills the requirement to submit a PPP in accordance with the Order.

#### 2.2 POTENTIAL IMPACTS

#### 2.2.1 FACILITY OPERATIONS

The modification and renewal of the ASF permit will enable Goodyear to install the upgraded air emissions control systems and allow the Facility to continue to supply Goodyear and its customers with the antioxidant product needed by global tire manufacturers to help prevent deterioration in the rubber tires they produce. This permit modification and renewal will support Goodyear's commitment to lowering air emissions in its operations and help protect the surrounding public and the environment.

#### 2.2.2 AIR EMISSION IMPACTS

Table 1 provides a summary of the annual air contaminant emissions from the Facility under the current ASF permit. Data for both 2024 actual emissions and the potential-to-emit for each of the criteria and other regulated air contaminants are presented below (See also page 3 of the July 17, 2025, updated ASF permit renewal application form).

Based on the information summarized in Table 1 above, and the air quality calculations performed, the predicted emissions of the regulated air contaminants from Goodyear's facility-wide operations will not result in impacts above the federal Clean Air Act's (CAA) National Ambient Air Quality Standards (NAAQS) or New York's DAR-1 SGCs or AGCs, once the air emissions control system upgrades have been completed and commissioned.

This analysis indicates that air emissions from the Goodyear Niagara Falls manufacturing operations are protective of human health and the environment surrounding the Facility.

#### 2.2.3 POTENTIAL PROJECT BENEFITS

#### 2.2.3.1 ENVIRONMENTAL BENEFITS

As a global, socially responsible corporate citizen, the Goodyear Niagara Falls facility conducts its business in accordance with the highest applicable legal and ethical standards. The facility strives



to contribute to sustainable economic development and environmental protection while seeking to improve the quality of life of our associates, families, community, and society in general. The Facility is committed to maintaining its ISO 45001 certification and to incorporating the ISO 14001 Environmental Management Standard into the way it conducts business.

Goodyear is committed to ethical and sustainable practices designed to protect its people and the planet, and the company is dedicated to providing a safe and healthy workplace. Modification and renewal of the ASF Permit will enable Goodyear to continue supporting and promoting these efforts. The following are examples of the company's commitment to sustainability and creating value for both its internal and external stakeholders.

#### Greenhouse Gas Emissions Program

Goodyear is committed to lowering greenhouse gas (GHG) emissions and energy consumption through various mitigation and reduction projects. In 2021, Goodyear announced its climate ambition, which includes a goal to reach net-zero Scope 1, 2 and certain Scope 3 GHG emissions by 2050, as well as a commitment to achieve near-term science-based targets by 2030, including reducing Scope 1 and 2 emissions by 46 percent and certain Scope 3 emissions by 28 percent, as compared to a 2019 baseline.

The Goodyear Niagara Falls facility is one of the most efficient Goodyear facilities in terms of GHG emissions. Additionally, when comparing Goodyear's Niagara Falls facility's energy and GHG emissions, they are the lowest among the Company's other chemical-manufacturing facilities, and Goodyear is committed to further reducing the carbon footprint of its Niagara Falls facility.

#### Zero Waste to Landfill Program

Goodyear established a Zero Waste to Landfill program expectation that applies to all Goodyear created or owned waste at our legacy Goodyear tire and chemical manufacturing facilities in 2006. The Facility complies with the Zero Waste to Landfill program and has monitoring measures in place, such as waste reports differentiated by waste types and disposal practices. The Facility manages and implements a detailed waste vendor approval process to help ensure that the wastes generated at the Facility are properly managed and disposed offsite using suppliers and vendors that are properly registered, permitted and approved for the wastes that they handle. All the Facility's waste vendors are required to comply with this program, and the Niagara Falls team monitors and audits vendors for compliance. Goodyear has continuously improved its waste management practices by maintaining corporate standards, processes, and systems to help ensure the appropriate disposition of waste and other materials. The Zero Waste to Landfill program benefits the local Niagara Falls community by helping ensure that the management and disposal of its waste streams is done following federal and state regulatory requirements in a responsible and safe manner.

#### Solvent Reduction Initiatives



Further, the Facility strives to reduce solvent usage and, consequently, solvent emissions at its manufacturing facilities.

<u>Goodyear's Responsible Operations Policy</u> outlines how the Company is focused on a culture of safety and operates in a manner that protects its people, customers, the planet, the Company, and its good name. The policy outlines the actions the Company takes in support of its commitment to corporate responsibility, safety, health, injury prevention, product quality, operational resilience, and the environment.

#### Goodyear Niagara Falls Community Involvement

Giving back to the communities in which Goodyear operates is a key component of the Company's sustainability strategy. For the past two years, Goodyear Niagara Falls associates have participated in the United Way Day of Care at Niagara Hospice for Niagara County. In addition, the facility has hosted a food drive for Heart, Love and Soul Food Bank, a local food bank serving Niagara Falls. Plans are also currently underway to host another food drive later this year, as well as a school supply collection drive targeted for August 2025.

#### Goodyear's Corporate Sustainability Program

Goodyear publishes an Annual Corporate Responsibility Report — charting the company's progress towards its sustainability goals. This is something the company has done since 1996. The most recent Corporate Responsibility Report and more information on Goodyear's commitment to sustainability can be found at Goodyear.com/responsibility.

#### 2.2.3.2 ECONOMIC BENEFITS

The Facility has been a key employer in the Niagara Falls community for almost 80 years, operating since 1946 and manufacturing products under the Goodyear name since 1957. The facility operates 24 hours a day, 7 days a week, with three, 8-hour rotating shifts and is ISO 9001 (Quality), 14001 (Environmental), and 45001 (Safety) certified.

The Facility employs 70 associates, most of whom are hourly associates represented by United Steelworkers Local 4-0277, Goodyear Unit. Total wages for the facility exceeded \$6.7 million in 2024, and those wages are anticipated to increase in 2025. Goodyear contributes more than \$160,000 annually to the Niagara Falls community through city, county, and school district taxes. Approximately 48% of the current Niagara Falls facility workforce lives in the City of Niagara Falls; the area that constitutes the majority of the Census Tracts identified in the Niagara Falls PEJA and DACs. This level of local employment demonstrates the economic benefit that the Goodyear Niagara Falls manufacturing plant provides to the local PEJA and DAC residents.

Wherever possible, the Facility sources materials and services from local suppliers and vendors. Through that effort, the Facility has procured nearly 90% of its materials and services from local suppliers and vendors over the past four years. The total annual spend budget for the Facility is



approximately \$50M, which translates to an even more significant figure if an economic impact multiplier is applied.

Modification and renewal of Goodyear's ASF Permit will continue to provide the overall economic benefit to the greater Niagara Falls community that the area has relied upon from Goodyear since the 1940s.

### STAKEHOLDER IDENTIFICATION & CONTACT LIST

A contact list consisting of the names<sup>1</sup>, addresses, phone numbers, and/or email addresses of stakeholders to the proposed project is provided in Appendix A. The contact list includes individuals and organizations with a direct stake in the proposed project and people and individuals and organizations that have expressed interest in the proposed project or similar projects affecting the same neighborhood or community.

To develop an initial contact list, Goodyear used geographic information services (GIS) to identify the residential properties located within the Disadvantaged Communities (DAC) surrounding the Facility and the PEJA located near the campus and expanded the contact list to include those residential properties located within a ½-mile radius of the Facility's boundary that potentially could be affected by the Facility operations. Figure 1 provides a representation of the ½-mile radius boundary used to compile the contact information of residential properties while Figure 2 depicts the DACs and PEJAs that could be affected by the Facility operations.

In addition, local community-elected and government officials, community leaders, civic and recreational organizations, environmental and religious groups were compiled through readily and publicly available online database resources and incorporated into the initial contact list. The current contact list includes federal, state and local government and elected officials; business owners, residents, and occupants; local civic, community, environmental and religious organizations; and local news media.

Goodyear will use this contact list to communicate and disseminate information about the proposed project and ASF Permit application review process to the affected community and stakeholders. At a minimum, this includes distribution of the written information and outreach materials described in Section 5 (below) to inform the community about upcoming public meetings and opportunities for public participation.

The contact list will be reviewed periodically and updated as appropriate throughout the ASF Permit application review process. Goodyear will update the contact list with any new stakeholders identified during the public meeting or execution of other PPP components. In addition, individuals and organizations can and will be added to the contact list upon request. Such requests should be submitted to the project liaison identified in Section 4. Other additions to the contact list may be

made at Goodyear's discretion or at the request of NYSDEC. Please refer to Appendix A for the complete contact list.

# 4. PROJECT ELECTRONIC MAILBOX AND PROJECT LIAISON

A representative from Goodyear's Chemical Communications Group will serve as the project liaison and be available during business hours. Goodyear has also established a dedicated project electronic mailbox at the following address:

Through the project liaison representative and electronic mailbox, residents and interested stakeholders can provide input to the project team, communicate any issues or concerns, and/or ask questions or request information. The Goodyear project liaison will monitor the electronic mailbox and respond in a timely manner and in a manner appropriate to the question or information request received. The Goodyear project liaison will also track and document public input, inquiries, questions, and information requests received, along with responses provided, and will provide this information to the Department pursuant to the reporting procedures described in this PPP.

# 5. PUBLIC OUTREACH ACTIVITIES

Goodyear will use a range of engagement strategies and public outreach activities to facilitate participation, involvement, and direct communication with the affected community during the permit application review process. Goodyear will begin to implement the public outreach activities outlined below once this PPP has been finalized and approved by NYSDEC.

Goodyear plans to hold a public information meeting to keep the public informed about the proposed project and the environmental permit review process. Goodyear will prepare, distribute, and post written information and materials, including a meeting notice and fact sheet, to encourage dialogue and solicit input from interested stakeholders during the permit application review process. In addition, Goodyear will send invitations to the list of public stakeholders and residents within a ½-mile radius of the facility, and supply window posters for posting in the windows of local businesses to ensure that the local stakeholders are adequately notified in advance of the planned meeting(s). All public outreach materials and information will be prepared and presented in an easy-to-read, understandable format, using plain language free of legal terminology, and geared towards a non-technical audience.

The public meeting notice and fact sheet will be made available and disseminated in English language. Based on Goodyear's efforts and review of the local demographics and Census Tract data of the PEJAs and DACs surrounding the facility, 100 percent of the population across the EJ/DAC Census Tracts either speak only English or speak English "very well." However, the public can contact the project liaison and electronic mailbox regarding the availability of language assistance and to request that the notice and fact sheet be translated into another language for



comprehension by non-English speaking or limited proficiency stakeholders, if needed. Please refer to Appendix B for detailed information used in the analysis regarding the need for language translation services.

#### 5.1 PUBLIC MEETING

At the discretion of NYSDEC and, depending on the scale and nature of a project, one or more public meeting(s) will be conducted in accordance with CP-29.

Goodyear will arrange for and facilitate a public meeting at a time that falls within the 30-day public comment period once the NYSDEC has completed its review of the ASF Permit modification and renewal process. Goodyear anticipates the meeting will be held at a venue located in the area near the Facility from 6:00 PM to 8:00 PM to:

- Inform the public about the proposed project and permit application review status.
- Provide the opportunity for stakeholders to ask questions and express concerns about the project and identify how to obtain information or answers to questions after the meeting has concluded.
- Inform attendees how they may submit written comments on the permit application to the NYSDEC during the public comment period and, if available, identify any applicable deadlines.

The venue will be located along easily accessible public transportation routes and will be large enough to accommodate interested stakeholders that could attend the meeting.

The Public Meeting(s) will be facilitated by Goodyear and/or ERM consultants on the project team (Project personnel) in person and/or via a videoconferencing technology platform (e.g., Microsoft TEAMS, ZOOM, etc.). A brief overview will be provided of the permit renewal process, including any relevant background information, details on the permitting action, scope of work, schedule, and community impacts. The second part of the meeting will include a question-and-answer portion where the floor will be opened for attendees to ask questions, make remarks, and/or express concerns. In addition, the following discussion points will be addressed:

- An update on the permit application review process and identify outstanding application requirements and future milestones in the application review process.
- Confirmation that the meeting is being held prior to NYSDEC's permitting decision for the project.
- The location of the online document repository and directions on how attendees may obtain and review materials relevant to the application, documents related to the meeting, and other public participation plan components.



- Information for the Project electronic mailbox and procedures for how attendees may
  obtain and review materials relevant to the application, documents related to the meeting,
  and other public participation plan components.
- Communication of any future opportunities for public participation.

Attendance will be recorded during the meeting using hardcopy sign-in sheets and recording of video conference participant identification. Goodyear will track the number of attendees for the meetings held during implementation of this PPP and, where feasible and applicable, identify any affiliation of participants and interests represented at the meeting. Goodyear will document meeting notes or minutes, along with a record of comments and questions raised in the meeting and respective responses and answers provided. Attendees not identified on the contact list will have the option to be added in the event of future meetings or information sharing.

#### 5.2 PUBLIC MEETING NOTICE PREPARATION AND DISTRIBUTION

Information regarding the details of the public meeting(s) and how to participate is contained in the mailing post card and window poster notice(s) shown in Appendix C. The notice has been prepared in English and, if needed, may be translated into additional languages. Through this notice, the public will be invited and encouraged to attend the public meeting either in-person or virtually.

Once the PPP has been approved by NYSDEC, the public meeting notice will be posted and available in the document repositories described in Section 6 of this document. At least two weeks before the public meeting, the notice will be published in the local daily newspaper that is published seven days a week and circulated throughout the Niagara Falls area. In addition, the public meeting notice will be mailed to the stakeholders identified in the contact list in Appendix A at least two weeks prior to the planned public meeting.

#### 5.3 FACT SHEET PREPARATION AND DISTRIBUTION

Factual information on the proposed project, including an overview, purpose statement, and potential impacts, is outlined in the reader-friendly fact sheet shown in Appendix D. The fact sheet is intended to be widely available as a plain language resource on the Project proposal for interested stakeholders. In addition, the fact sheet outlines how interested stakeholders can: participate in the permit application review process; access the document repositories to review relevant application materials prior to the public meeting; and contact the project team to obtain additional information. The fact sheet has been prepared in English, and if needed, may be translated into additional languages.

Once the PPP has been approved by NYSDEC, the fact sheet will be posted and available in the document repositories described in Section 6 of this document. No later than two weeks prior to the public meeting, Goodyear will post the fact sheet to the online repository and distribute the fact sheet to the paper copy repository to provide stakeholders with relevant background on the



proposed project and facilitate meaningful participation during the meeting. Upon request, the fact sheet will be distributed via email or mail to those requesting it.

The fact sheet will also be provided to business or facilities within the vicinity of the project site for posting visible to the public. For example, it may be provided for posting on bulletin boards located in the lobby of public facilities such as libraries, schools, grocery stores or community centers near the Facility.

#### 5.4 DISTRIBUTION OF NOTICE OF COMPLETE APPLICATION

Once NYSDEC determines the application for the proposed Project is complete and provides the Notice of Complete Application (NOCA) to the Applicant, Goodyear will make available the NOCA and draft ASF Permit, if applicable, to any identified interested parties who specifically request a paper copy of the documents, to provide notification regarding the start of the NYSDEC public comment period and to announce the deadline for submission of written comments to NYSDEC. The NOCA will also be provided electronically if requested by interested parties by accessing the Goodyear online document repository and/or through the NYSDEC's Environmental Notice Bulletin (ENB). If the NOCA is available at the time of the meeting, Goodyear will have copies of the NOCA available at the public meeting for distribution in printed form. If the NOCA is not available at the time of the meeting, Goodyear will provide explicit instructions on how to access the document repositories and inform the attendees that, once available, the NOCA will be included in those repositories.



#### 5.5 ADDITIONAL OUTREACH AND MATERIALS

Goodyear will print and distribute posters for placement in the windows of local businesses announcing the public meeting(s), the dates(s) and time(s) of the planned public meeting(s). Appendix E provides a sample poster for placement at local businesses.

#### DOCUMENT REPOSITORIES

In addition to the paper copies of the permit application documents posted in the public repository location(s) identified in section 5.3, Goodyear has developed an online portal for those residents and stakeholders to access electronically. The online document repository has been established for the community and interested stakeholders to access and review information about the permit modification and renewal. The online document repository provides information and documents relating to the project and permit application.

The online document repository will be updated throughout the application process with permitrelated information and written materials (i.e., application forms and supporting materials, draft permit, fact sheet, statement of basis (where applicable), the NOCA provided by the NYSDEC, etc.).

### 7. SUBMISSIONS

#### 7.1 PROGRESS REPORT

No later than two weeks after the public meeting(s) described in Section 5, Goodyear will submit a progress report to NYSDEC in the form of a brief memorandum or cover letter. At a minimum, the progress report shall summarize:

- Progress to-date in implementing the approved PPP, including the components of the plan yet to be implemented, and the timeline for completion of the PPP;
- All substantive concerns raised to-date, either during the public meeting, or, received by the project liaison, along with responses provided;



- All resolved and outstanding issues; and
- The components of the plan yet to be implemented and an expected timeline for completion of the plan

The progress report will become part of the application record and will be posted to the local public repository and to the online document repository so that it is readily available to the public.

#### 7.2 REVISED REPORT AND WRITTEN CERTIFICATION


Upon completion of the PPP, Goodyear will submit written certification to NYSDEC to certify that it has fully executed and complied with the approved PPP. As part of that certification, Goodyear will provide a revised report detailing activity that occurred subsequent to the initial report as described in Section 7.1. The certification shall be signed by Goodyear, or its agent, and submitted to NYSDEC prior to the Department making a final decision on the application.


As applicable, the Final Summary Report may serve as the Progress report described in Section 7.1 to avoid potentially duplicative reporting. Goodyear will include, or append, any documentation that supports the final summary report, such as the meeting sign-in sheet(s), record of attendees/participants, meeting presentation, notes or minutes, summary of questions and answers, and copy of newspaper notice or other proof of publication.



## **BACKGROUND**

The Goodyear Tire & Rubber Company ("Goodyear") operates manufacturing facility at 5500 Goodyear Drive in the City of Niagara Falls, New York (the "Facility"). The Facility was originally built in 1946 and manufactures Polystay 100, an antioxidant, antiozonant, and anti-flex cracking agent used in manufacturing tires, belts, and other products that contain rubber compounds. Polystay 100 provides long-term ozone, oxygen, and heat protection that is critical to minimize deterioration, promote safety, and extend the useful lives of tires and other products. The Facility supplies Polystay 100 to customers and Goodyear tire manufacturing facilities in over 18 countries in North and South America, Europe, and Asia.

## PROJECT DESCRIPTION

The Facility has an existing Air State Facility Permit (9-2911-00036/00151), which became effective on June 15, 2009, with no expiration date (the "Permit"). In 2018, the New York State Department of Environmental Control ("NYSDEC") Division of Air Resources requested that Goodyear submit an application to renew the Permit so the Permit could be reissued with a 10-year permit term. NYSDEC also requested that Goodyear conduct air emissions testing, and based on the results of that testing, NYSDEC predicted, through its modeling, that the Facility's emissions, including emissions of orthotoluidine, were estimated to exceed guidelines established by the NYSDEC.

Under an Order on Consent with the NYSDEC entered in January 2025, Goodyear was required to prepare and submit to NYSDEC an Air Pollution Control Engineering Study describing a proposal to design, install, and test upgraded air emissions control equipment at the Facility. Specifically, the Facility is replacing the existing wet scrubber and incorporating a new Regenerative Thermal Oxidizer ("RTO") into the Facility's air emissions control systems that will be designed, engineered, and installed to capture and control air particulates and organic air contaminants from the Facility. These upgraded measures and equipment are expected to reduce air emissions from the Facility to ensure compliance with New York's air guidelines.

Table 1 below provides a summary of the annual air contaminant emissions from the Facility under the current ASF permit. Data for both 2024 actual emissions and the potential-to-emit for each of the criteria and other regulated air contaminants are presented.

## PROJECT BENEFITS TO THE ENVIRONMENT AND THE COMMUNITY

The modification and renewal of the Facility's Permit will enable Goodyear to install the upgraded air emissions control systems, which will allow the Facility to continue to supply Goodyear and other customers with Polystay 100 while supporting Goodyear's commitment to lowering air emissions at the Facility and helping Goodyear protect the surrounding environment. The following are a few examples of the company's commitment to sustainability and creating value for both its internal and external stakeholders:

- Commitment to sustaining its ISO 45001 certification and incorporating the ISO 14001 Environmental Management Standard into the way it conducts business;
- Developed a Greenhouse Gas Emissions Program which includes a goal to reach net-zero greenhouse gas emissions by 2050.
- Established a Zero Waste to Landfill program that applies to all Goodyear created or owned waste;
- Reduced solvent usage and, consequently, solvent emissions by 38 percent from the 2010 baseline;



- Instituted <u>Goodyear's Responsible Operations Policy</u> which outlines the actions the Company takes in support of its commitment to corporate responsibility, safety, health, injury prevention, product quality, operational resilience and the environment;
- Published an Annual Corporate Responsibility Report that charts the company's progress towards its sustainability goal, available at: Goodyear.com/responsibility;
- Established "Giving Back to the Community" projects including United Way Day of Care at Niagara Hospice for Niagara County, hosted a food drive for Heart, Love and Soul Food Bank, and school supply collection drive targeted for August 2025.

Goodyear has been a key employer in the Niagara Falls community for almost 80 years. The Facility employs 70 associates, most of whom are hourly associates represented by United Steelworkers Local 4-0277, Goodyear Unit. Total wages for the facility exceeded \$6.7 million in 2024, and those wages are anticipated to increase in 2025. Goodyear contributes more than \$160,000 annually to the Niagara Falls community through city, county, and school district taxes. Approximately 48% of the current Niagara Falls facility workforce lives in the City of Niagara Falls; the area that constitutes the majority of the Census Tracts identified in the Niagara Falls PEJA and DACs. Wherever possible, the Facility sources materials and services from local suppliers and vendors, and through that effort, the Facility procured nearly 90% of its materials and services from local suppliers and vendors over the past four years.

## HOW TO PARTICIPATE IN THE PERMIT PROCESS

The Permit modification and renewal application has been submitted to the NYSDEC and is currently under review by the NYSDEC Division of Air Resources, and the Division of Environmental Permits. NYSDEC is accepting comments from the public about the application and this project until [Date TBD].
